# 2. Evaluated Points for the Certification

The following points were evaluated in the certification.

# **Iwatsuki Logistics (Logistics)**

- Environmentally friendly efforts such as adopting LED lighting and water-saving toilets within warehouses and offices
- · Having facilities and specifications that sufficiently meet the latest tenant needs

#### Baraki Logistics (Logistics)

- Environmentally friendly efforts such as adopting double-folded plate roofing material and water-saving toilets
- Improving the convenience of tenants by establishing refresh corners at several places as well as installing universally designed elevators, taking into consideration diversity among users

### Honmachibashi Tower (Office)

- Environmentally friendly efforts such as implementing air-conditioning and ventilation by adopting energy-saving glass and taking in outside air
- Implementing BCP measures such as installing standby power supply for tenants

# 3. Overview of DBJ Green Building Certification

DBJ Green Building Certification Program was launched by Development Bank of Japan Inc. ("DBJ") for the purpose of supporting the properties which give proper care to environment and society ("Green Building"). The program evaluates, certifies and supports properties which are required by society and economy. It makes comprehensive assessment of properties, while evaluating various factors which range from properties' environmental features to their communication with stakeholders, such as disaster prevention and proper care for surrounding communities. Since August 2017, JREI evaluates and certifies properties and DBJ controls the DBJ Green Building Certification Program.
