Notice Concerning Determination on Prices and Other Conditions with Regard to Issuance of New Investment Units and Secondary Offering of Investment Units

Star Asia Investment Corporation ("Star Asia REIT") announces that it determined at the Board of Directors meeting held today the issue price, offer price of secondary offering and other conditions concerning issuance of new investment units and secondary offering of investment units of Star Asia REIT that was resolved at the Board of Directors meeting held on March 16, 2016, as described below.

4. Basis for calculation of issue price and offer price of secondary offering

Issue price was determined based on the provisional conditions for the issue price (90,000 yen or more and 100,000 yen or less), and according to the book building method by securing opinions mainly from institutional investors, etc.

As a result of the survey according to the book building method, the following characteristics were identified.

- 1) The total number of demanded investment units declared sufficiently exceeded the number of investment units subject to the issuance of new investment units through primary offering and the secondary offering of investment units through over-allotment.
- 2) The total number of demands declared was large.
- 3) As for the distribution of declared demands by price, there are many demands at the upper price limit of the provisional conditions.

Comprehensively considering the results of the survey according to the book building method above, the securing of as many investors as are required for listing, the market environments including the real estate investment trust securities market circumstances, and the risk of price fluctuation during the period before the date of listing, the issue price was determined to be 100,000 yen, at which the demand will exceed the number of investment units subject to primary offering and secondary offering of investment units through over-allotment.

In addition, the paid-in amount (issue amount) for the issue of new investment units through primary offering was determined to be 96,250 yen.

Moreover, the offer price for secondary offering through over-allotment was determined to be 100,000 yen, the same as issue price (offer price) for primary offering, and the paid-in amount (issue amount) for the issuance of new investment units through third-party allotment was determined to be 96,250 yen, the same as the paid-in amount (issue amount) for primary offering.
